2	30/7/2021	MBA	Two MBA students were caught copying from matter written on the desk. The contents on the desk were relevant to the subject for which the exam was being held. They have accepted the malpractice. The MEC as per the guidelines recommends that vide Sl. No. 2-I(a), the Candidate has been denied of the benefit of performance of that particular course (in SEE) in which he has been booked under Malpractice & also denied subsequent makeup exam.
3	23/10/20	BE (E & C)	Total of 14 students were involved in asking answers and the exchange of materials related to the course in whatsapp group during the exam. The content present in the whatsapp group was relevant to the subject for which the theory exam was being held. All the students have accepted that they were involved in the malpractice. The MEC as per the guidelines recommends that vide Sl. No. 2-I (a), all the Candidates have been denied of the benefit of performance of that particular course in which they have been booked under Malpractice. They will be allowed to appear for this course in Fast track 2021.

4	23/10/2021 & 09.03.2021	BE (ME)	One student was caught in possession of chits and the content in the chit was relevant to the subject for which the theory exam was being held. He has accepted that the chits were in his possession and had copied from it. The MEC as per the guidelines recommends that vide Sl. No. 2-I(a), the Candidate has been denied of the benefit of performance of that particular course in which he has been booked under Malpractice Another student was also caught in possession of smartphone which contained softcopy of subject matter. The content in the smartphone was relevant to the subject for which the exam was being held. He has accepted that the smartphone was in his possession and had copied from it. As per the guidelines, vide Sl. No. 2-I (a) and 1-IV (d), the Candidate should be denied the benefit of performance of that particular course in which he has been booked under Malpractice and should be debarred from appearing for one more subsequent examination i.e. Fasttrack examination. However considering that the candidate is in the final year & has a good CGPA, the MEC recommends that the Candidate should be denied the benefit of performance of that particular course in which he has been booked under Malpractice.
