Preamble	<p>Term of the previous BoS completed in June 2021. New Board of Studies for each of the program is constituted as per the guidelines of UGC and VTU. Separate BoS for the Physics, Chemistry and Mathematics have been formed from this year. The term for the BoS is for the duration of three years, i.e, from 2021-22 to 2023-24. <b>Agenda No.14.2</b>	<b>To appraise about NBA Expert team visit for two M.Tech. programmes and submission of NAAC Self Study Report</b>
Preamble	<p>NBA expert team visit for M.Tech (Structural Engg.) and M.Tech (Machine Design) is scheduled from 3<sup>rd</sup> - 5<sup>th</sup> Dec 2021. It will be conducted in the Online mode. However, one of the representatives of NBA will be present in the college as expert. Preparations are in progress.</p> <p>The IIQA (Institutional Information for Quality Assurance) submitted to NAAC is accepted and we are permitted fill the Online Self Study Report (SSR). Two workshops on NAAC process were conducted for faculty members.. The NAAC accreditation of our institute is valid upto 1<sup>st</sup> Dec 2021. We seek your valuable suggestions for the accreditation preparation.</p> <p><b>Resolution:</b> The members were happy about the preparation made for the NBA expert team visit and also for the NAAC SSR submission. Preamble	<p>As per the notification of VTU, change in the scheme of teaching (Curriculum) for B.E program is being done.</p> <p>Main Features:</p> <ul style="list-style-type: none"> <li>• No. of credits reduced from 175 to 160 credits.</li> <li>• Ability Enhancement courses in all the semesters</li> <li>• Mandatory internship after 2<sup>nd</sup> semester (3weeks), 4<sup>th</sup> semester (4 weeks) and 6<sup>th</sup> semester (24 weeks)</li> <li>• Credits of each course is 3</li> <li>• Flipped Classroom</li> </ul> <p>Presently, the complete syllabus for 1<sup>st</sup> year B.E. only is prepared. The overall Scheme of Studies and Evaluation, and the 1<sup>st</sup> year syllabus would be presented. We seek your advice and approval.</p> <p>The institute had initiated the change in the curriculum for B.Arch program also. But, from the CoA website it is found that CoA is likely to initiate change in the syllabus as per NEP from next year. Hence, it is proposed to change the syllabus from next year. We seek your approval.</p>

a)	<p>i) The members were informed about the courses offered by the industry such as "Creintors Automation Solutions Pvt. Ltd., Belagavi", for MCA students.</p> <p>ii) 100 hours duration course by Honeywell, Bangalore.</p> <p>iii) Certification course by the Google.</p> <p>iv) Certification course in Nano Technology by Centre of Excellence in Nano Technology, KLS Gogte Institute of Technology, Belagavi.</p> <p><b>Discussion Resolution :</b></p> <p>The members were pleased to know that the students are getting opportunity to undergo the courses offered directly by the industries. This will help the students to know about the latest trends in the Industry. Approval was given for such courses and was suggested that many more such courses could be introduced.</p>
b)	<p>To seek inputs on fast track semester in the new scheme.</p> <p>The members were appraised that as per the new B.E scheme 20-21 the students have to undergo internship after completing 1<sup>st</sup> year, 2<sup>nd</sup> year and 3<sup>rd</sup> year B.E.The students who will be having backlog will be registering the back log courses during fast track. It will be inconvenient to provide the solution for this</p> <p>The members expressed that it has to be deliberated and discussed before finalizing and it was suggested to take it up during the next meeting.</p>
c)	<p>SEE for the ability enhancement courses (AEC)</p> <p>Members were briefed about the process of evaluation (CIE and SEE) for these courses. CIE would comprise of written test, quiz's and more of activities outside the class. The members were suggested to guide us regarding SEE.</p> <p><b>Decision:</b> Members expressed that it is difficult to evaluate these courses in the form of SEE.</p> <p>It was opined by all the member that the such courses which involve more activities, continuous evaluation will be more effective rather than SEE. It is recommended to evaluate the performance for these courses through CIE only.</p>
