The Executive Committee, after consideration of the same, has decided to grant approval for introduction of **3-year Full-time Diploma Course** as under:



- The institution should follow the course curriculum i.e. courses, periods of study and subjects of examination for the Diploma course as well as the eligibility criteria for admission to the course as prescribed by the Council in the said Guidelines.
- The institution shall be required to appoint faculty to fill up any vacancy, as may be required, within 15 days in case of any faculty leaving the institution.
